#### STANDARD TERMS AND CONDITIONS

### 1. OCCUPATION TIMES

- 1.1. Arrival time: after 2pm on the arrival date.
- 1.2. Departure time: before 10am on the departure date. The Property must be vacated timeously for the cleaners to begin cleaning the Property.

### 2. CANCELLATION POLICY

If the tenant decides not to proceed with the rental of the Property after the booking has been confirmed and the deposit amount has been paid, then the following cancellation policy shall be applicable:

- 2.1. if the booking is cancelled more than 60 days prior to the arrival date, a cancellation fee of 20% of the deposit amount is charged;
- 2.2. if the booking is cancelled more than 21 days but less than 60 days prior to the arrival date, a cancellation fee of 50% of the deposit amount is charged;
- 2.3. if the booking is cancelled within 21 days prior to the arrival date, a cancellation fee of 100% of the deposit amount is charged.

# 3. BREAKAGES AND DAMAGE

- 3.1. In order to protect the owner of the Property against any damages to the Property and its contents, a breakage deposit is required.
- 3.2. The value of any broken, damaged or missing articles shall be deducted from the breakage deposit and should the breakage deposit not be sufficient to cover the damage, the tenant will be invoiced for the outstanding amount.
- 3.3. The breakage deposit will be refunded within 7 days after the departure date.

### 4. HOUSE RULES

- 4.1. No more than 8 guests (4 adults and 4 children) are permitted to occupy the Property.
- 4.2. No smoking permitted on the Property.
- 4.3. No pets allowed.
- 4.4. Do not remove keys from interior doors.

- 4.5. Do not light fires anywhere other than in designated fireplaces and barbeque / braai facilities.
- 4.6. Please adhere to Boggomsbaai rules, a copy of which will be in the house.
